Remember to Change Credit Year for 2016 Annual Compliance reported in 2017



As you already know, the required reporting of all officers annual compliance for 2016 should be completed by December 31. The initial compliance reports have been run and sent to all agency SPOCs showing each officer's current status. When submitting Formatta forms, you should ONLY submit 6 forms for each officer; reporting that the requirement has been completed or the officer is excused for the year. If you are submitting a spreadsheet, make sure all information is correct and the data is entered in the required format for import. Contact Shirley Micallef if you have questions.

IMPORTANT NOTICE TO SPOCs: On January 1, 2017, the Formatta Forms for submitting training will show the credit year as 2017. MAKE SURE to change the CREDIT YEAR to 2016 when you are reporting any compliance training for 2016.

Before Hiring

Always Check the National Decertification Index (NDI)

Officers whose certificates/licenses have been revoked/suspended/relinquished in Nevada or another state **cannot be certified in Nevada**. When hiring new officers, it is requested that the National Decertification Index (NDI) be checked as part of your agency's employment process. This Index is updated by most states in the country with the name and information of their offending officers. You are then able to follow up with the reporting agency regarding the specifics of the revocation/suspension/relinquishment.

It is easy to set up a login to the registry by going to the IADLEST website at <https://iadlest.org> and accessing the Featured Projects on the left hand side and clicking on the link for NDI. You should search this national registry for each person considered for employment as part of your normal background check procedures.
