NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Commission on Peace Officer Standards and Training is proposing the adoption and or amendment of regulations pertaining to Chapter 289 of the Nevada Administrative Code.

A workshop has been scheduled for **8:00 a.m. on Thursday, October 26, 2023, at the Southpoint Hotel/Casino, 9777 Las Vegas Blvd., S., Napa Room B, Las Vegas, NV.** The purpose of the workshop is to solicit comments from interested persons on the following general topic(s) that may be addressed in the proposed regulations:

TOPIC

NAC REGULATION

- A.** Discussion regarding the creation of standards, pursuant to SB 323, *for the reciprocity of a person who has been certified as a category III peace officer or its equivalent by the certifying authority of another state or who has successfully completed a federal law enforcement training program that is equivalent to a category III peace officer in this State.*

1. The Executive Director may award a basic certificate to any officer working in an assignment equivalent to the category III Nevada officer position who has been certified by the certifying entity of another state, where that state has a statewide certifying entity, or has successfully completed a Federal Law Enforcement Training Centers of the United States Department of Homeland Security training program regarding custody and detention approved by the Commission or provides verifiable evidence of training equivalent to category III training in Nevada when employed in a state that does not have a statewide certifying entity for custody and detention assignments, and who meets the minimum standards for appointment established pursuant to [NAC 289.110](#) if:

(a) The Commission or its designee has determined that the course of training required for the certification or employment from that other state and was at least equivalent to the basic training course for category III certification;

(b) The certification of the officer in the other jurisdiction has not been revoked or suspended; in the case where no certification is required in that other state, no discipline or acts that, if occurred in Nevada, would be cause for revocation or suspension.

(c) Not more than 60 months have lapsed since the officer was employed full time in the other jurisdiction as a custody or detention officer;

(d) The officer has satisfactorily completed a training course that is approved by the Executive Director which consists of a minimum of 40 hours of training that satisfies the requirements established by the Commission pursuant to subsection 1 of [NAC 289.300](#) in:

- (e) The officer passes the state certification examination with a score of at least 70 percent; and
- (f) The officer passes the state physical fitness examination for the appropriate category of peace officer as described in [NAC 289.205](#).
