**North West:** Carson City / Storey / Churchill / Washoe

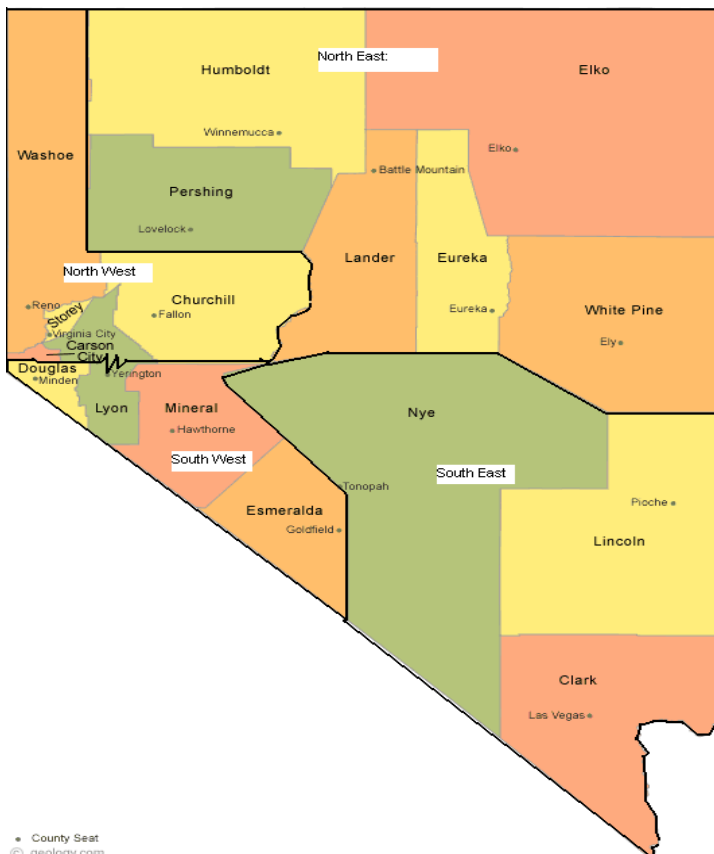
