#### **2014 Training Compliance**

All reporting of annual compliance for 2014 should have been submitted to POST by **December 31, 2014**. The compliance reports have been run and letters of non-compliance will be going out soon. Starting this year, these letters will be sent via email to each agency for distribution to their non-compliant officers.

***NOTICE to SPOCs: When submitting training for 2014 Compliance, MAKE SURE to change the Credit Year to 2014 on the Formatta form.***

#### **Training for Dog-Related Incidents and Encounters**

The primary goal of this training includes ensuring public and officer safety as well as considering community needs and demands where dogs happen to be present.

#### **Update to Management Certificate Requirements**

In the last Commission Meeting, the requirement for an officer to complete a minimum of 6 college credits for a Management Certificate was removed. The other requirements remain the same.
