## **NEW REQUIREMENTS & FORM for** "Professional Certificate Application"

The requirements for Intermediate and Advanced certificates are changing. The new qualifications are based on years of Nevada peace officer service, formal education acquired, and the POST training achieved. A new online form is now available on the POST Formatta Website; which allows for selecting the desired certificate, specifying the officer's qualifications, attaching required documents, and submitting the application with a click of a button.

### NEW ONLINE FORM "Employment Personnel Action Report"

New hire? Now, when you hire a new officer, this information can be easily and quickly sent to POST by using the new online Employment PAR form. No more paper, mailing, or signatures are required. Just click a few radio buttons, fill in the officer's information, and submit. Remember, if you need a copy of any Formatta submission, you can easily save an electronic copy or print a hardcopy for filing.

### **UPDATED ONLINE FORM**"Update—Personnel Action Report"

The first Formatta form POST made available back in 2011 has been updated. The changes to the form are minor; but are important. When an officer's position has changed within an agency, inform POST an additional POST certification will be required by the officer within the next 12 months. Also, the NAC289.290 Notification has been made easier by removing the need for any recommendation of action.

### **Update from the Commission Meeting of May 2, 2013**

NAC289.230 annual 24 hour training requirements for continuing education and/or skill proficiency was discussed. This topic was sent back to POST Staff for further review and is again on the agenda for the upcoming meeting July 24-25 in Ely.

NAC289.140, 289.150, 289.160, 289.170 minimum standards of training are in the final phases of being updated. Look for these new performance objectives to be available soon.
