2015 Annual Compliance

It is that time again for an officer's annual compliance training to be completed. All reporting of annual compliance for 2015 should be submitted to POST by December 31, 2015. Every year as a requirement to maintain basic certification, an officer must demonstrate proficiency in the five required critical skills plus 12 hours of agency training (or have a valid excuse as indicated by the pull-down selection in the Formatta Form). The initial compliance reports have been run and sent via email to the agency single-point-of-contact providing the current status of any officer in their agency that shows out of compliance. Agencies that are submitting spreadsheets for import should send them to Shirley Micallef at smicallef@post.state.nv.us.
