#### September Commission Meeting:

On Wednesday Sept<mark>ember 5</mark>, 2018 in Las Vegas Nevada, the POST Commission held a Public Commission Meeting.

Commission approved a revision to the POST administrative manual (policy) mandating that when a peace officer seeking certification under the reciprocity process (pursuant to NAC 289.200(2)) performs the POST physical fitness test, it will be administered by POST or its designee.

There was one revocation of a Category III Basic Certificate based on a conviction for two Category B felonies.

There was one revocation of a Category III Basic Certificate based on a conviction for a Category E felony.

There was one revocation of a Category I Basic Certificate based on a conviction for a Gross Misdemeanor.

# **Driving is a Perishable Skill**

As law enforcement personnel, risk is always present in our daily world. Operation of vehicles during the course of our duties ranks near the top of the risk scale for you and your agency. Like defensive tactics and firearms training, driving is a perishable skill. Treat every time you drive, both on and off duty, as a training opportunity. Studies have shown that in a stressful situation, we perform as we have been trained. Shuffle steer for best vehicle control, meaning don't let you hands cross on the steering wheel. "Steer to the rear" away from a collision in the event an errant driver crosses your path. We tend to go where we look; therefore, if you don't want to hit something, don't look at it! If you lose control, don't stare at that fixed object on the side of the road; look at the open road ahead. Be vigilant and aware of your surroundings. Unfortunately, we lose too many officers throughout the nation annually in driving related incidents. Tragically, between 2015 and 2018 we have lost the same number of officers to traffic related incidents as we have lost to gunfire. Remember to train, be alert and limit distractions. Like your ballistic vest, **ALWAYS WEAR YOUR SEATBELT!**
