The next POST Commission Public Comment Hearing, Workshop and Meeting is scheduled for November 8th, 2021 at 1:00pm. It will be held at the South Point Hotel and Casino, Napa Room B, 9777 Las Vegas Blvd. South, Las Vegas.

The Public Comment hearing being held is to receive comment from interested persons regarding the adoption, amendment and repeal of regulations pertaining to chapter 289 of the NAC:

Amend NAC289.110(1) to clarify minimum hiring standards regarding high school graduation

Amend NAC289.200(4)(b) revise timeframe to conduct physical fitness exam for reciprocity

Amend NAC289.140 to add ARIDE to the basic course for category I

The workshop will consist of further discussion to amend NAC289.047 which defines Executive level position.

The regularly scheduled meeting will be held immediately after the workshop
