## **Summary of POST Commission meeting held February 24, 2022 in Pahrump**

### **Workshop:**

Public comment and suggestions were made regarding the possible revision of NAC 289.270, removal of or changes to agency position requirement to qualify for the Executive Certificate and removal of/changes to minimum requirements for advanced certificates a peace officer must hold to qualify for the Executive Certificate. Subject was continued to the regularly scheduled meeting.

### **Regularly scheduled meeting –**

- Commission agreed to continue the rule making process to revise NAC289.270 and possibly NAC289.047(Definition of Executive Level position).
- **3 revocations at this meeting:**
  - Jovan Motley for 1 count Attempt asking or receiving bribe by public officer (Category D Felony/Gross Misdemeanor) and 1 count Attempt possession of a portable telecommunication device by a state prisoner (Category E Felony/Gross Misdemeanor)
  - Eduardo Bueno for 1 count Conspiracy to commit oppression under the color of office (Gross Misdemeanor) and 1 count Oppression under the color of office (Category D Felony)
  - Nicholas Diaz for 1 count Conspiracy to commit oppression under the color of office (Gross Misdemeanor) and 1 count Oppression under the color of office (Category D Felony)
- **3 Executive Certificates were awarded:**
  - Chief Kevin McKinney of Carlin Police Department
  - Captain David Boruchowitz of the Nye County Sheriff's Office
