### Personnel Changes at POST Basic Academy

As of January 3, 2022, KC Haase has assumed the position of Academy Commander for the POST Basic Academy. Training Specialists/TAC Officers will be Leighton Barbin and Dan Nolan (Cat I Academy) and Warren Turner (Cat II & III Academy).

### New Training Specialist

Nevada POST is happy to welcome Dan Nolan as our newest Training Specialist for the POST Basic Academy. Dan is a Veteran of the US Army, a graduate of the FBI National Academy and has over 25 years in Law Enforcement in Nevada and California. Please help us welcome Dan to the team.

#### Category II and III Basic Academy-Pilot Program

Nevada POST has traditionally conducted a combined Category I, II and III Basic Academy conducted over the course of 17 weeks. Because the program was combined, often the required NAC training curriculum/activities was not designed or presented in a "job-task specific" method. Additionally, scheduling constraints often resulted in Category II and III cadets participating in training that was not NAC required.

Beginning with Academy Class 2022-01, Nevada POST will be running a pilot program where we will conduct a "stand-alone" Category II and Category III Academy. The Category II & III Academy would run in conjunction with the Category I training program however cadets would have separate schedules and not be required to all attend the same training at the same time. Specific areas of NAC required training would be more tailored to fit the job requirements of Category II and III Peace Officers. POST had previously conducted a survey of Category II and III agencies to determine if there was sufficient interest in such a program and the results revealed that a pilot program would be justified. Class 2022-01 begins on January 24<sup>th</sup>, 2022 and the pilot program will be implemented if there is sufficient enrollment of Category II and/or III cadets. ## Nevada POST Participates in IADLEST Research Study

Beginning January of 2022, Nevada POST will participate in a nationwide research study of academy training methods. In conjunction with US Dept. of Justice and the International Association of Directors of Law Enforcement Standards and Training (IADLEST), Nevada POST Academy Class 2022-01 will participate in the Academy Innovations research project. Nevada POST was honored to be chosen as one of only 6 academies in the US to participate in the study. The study is designed to evaluate the efficacy of integrative curriculum design, which involves arranging courses around common themes and reinforces knowledge from different but related subject matter areas. Using Communication Skills as the foundational theme, the study will integrate those skills into Vehicle Stops and Response to Persons in Crisis training over a 16-week period. Once the results are compiled and published, POST will share this information with all Nevada agencies. We look forward to participating in this study.
