#### **NOTICE OF PUBLIC MEETING (NRS 241)**

NOTICE IS HEREBY GIVEN THAT STARTING AT 8:30 A.M. ON THURSDAY MAY 4, 2017, THE COMMISSION ON PEACE OFFICER STANDARDS AND TRAINING WILL HOLD A WORKSHOP AND REGULARLY SCHEDULED MEETING AT THE COMMISSION ON PEACE OFFICER STANDARDS AND TRAINING, CLASSROOM 2, 5587 WA PAI SHONE AVENUE, CARSON CITY, NEVADA.

TOPIC <u>NAC REGULATION</u>

A. The Commission to discuss revisions to the requirements for maintaining a basic certificate. This revision under 289.230 5(a) would clarify the term firearm to include wording for the firearm type. In section 7, add a new subsection (d) that when an officer is hired, rehired, or reinstated on or after July 1 of a reporting year, they must satisfy the requirements of paragraphs (b) to (e), inclusively, of subsection 5 and show proficiency in the use of each firearm type he or she is authorized to use before resuming his or her duties as a peace officer.

B. The Commission to discuss revisions to the requirements for course certification by a provider of training located outside of the state of Nevada. This change would require the provider to have their programs certified by the International Directors of Law Enforcement Standards and Training National Certification Program.
