The language is to provide for the revocation of POST certification for a conviction constituting a Misdemeanor Crime of Domestic Violence without a request from the agency.

The change would allow a Nevada certified Category I peace officer to leave employment with a Nevada agency and go to a Federal law enforcement agency as federal officer within Nevada or a Nevada law enforcement academy certified by the Commission on Peace Officer Standards and Training without their Nevada peace officer certification expiring while employed.
