AMENDED NOTICE OF PUBLIC MEETING (NRS 241)

THE PURPOSE OF THE HEARING IS TO RECEIVE COMMENTS FROM ALL INTERESTED PERSONS REGARDING THE ADOPTION, AMENDMENT AND REPEAL OF REGULATIONS PERTAINING TO CHAPTER 289 OF THE NEVADA ADMINISTRATIVE CODE (NAC) (THIS PUBLIC COMMENT HEARING HAS BEEN PREVIOUSLY NOTICED AS REQUIRED BY NRS CHAPTER 233B):

NAC 289.110(5) The provisions of subsection 4 do not apply to a person who has been convicted of an offense involving the unlawful use, sale or possession of marijuana if the offense is not unlawful at the time the person submits an application for certification as a peace officer.

The Commission to discuss and take possible action to adopt, amend or repeal their regulations as follows:

A. LCB File R004-23 – Amend NAC 289.110 to accommodate recent law changes regarding marijuana. NAC 289.110(5) The provisions of subsection 4 do not apply to a person who has been convicted of an offense involving the unlawful use, sale or possession of marijuana if the offense is not unlawful at the time the person submits an application for certification as a peace officer.

- **B.** LCB File R005-23 Amend NAC 289.300(1)(b) "a person enrolling in a basic training program *may* be required to pass...."
- C. LCB File R006-23 Amend NAC 289.200(4)(a) to remove the requirement that the physical fitness examination be passed "not later than 16 weeks after the first day" and instead require the physical fitness examination to be passed "during" the academy.
- **D.** LCB File R007-23 Amend NAC 289.200(8) to remove the "full-time" requirement to maintain the basic certificate.

Miller's (formerly employed with the Nevada Department of Public Safety) Category I and III basic certificates based on a conviction of, or entry of a plea of guilty, guilty but mentally ill or nolo contendere to a felony. The conviction(s) which have led to this action are: COUNT I – ATTEMPT LEWDNESS WITH A CHILD UNDER THE AGE OF 14 (Category B Felony-NRS201.230(2)-NOC 60471) (Clark County) and COUNT I-ATTEMPT MISCONDUCT OF A PUBLIC OFFICER (A category "E" Felony, in violation of NRS 197.110 and NRS 93.153) (White Pine County). Possible action may be revocation of the Category I and III basic certificates.

8. DISCUSSION, PUBLIC COMMENT, AND FOR POSSIBLE ACTION.

Hearing pursuant to NAC 289.290(1)(g) on the revocation of Michael O'Farrell's (formerly employed with the Nevada Cannabis Compliance Board) Category I basic certificate based on a conviction of, or entry of a plea of guilty, guilty but mentally ill or nolo contendere to a felony. The conviction(s) which have led to this action are: COUNT I-DRIVING UNDER THE INFLUENCE OF ALCOHOL AND/OR CONTROLLED OR PROHIBITED SUBSTANCE, ABOVE THE LEGAL LIMIT, RESULTING IN SUBSTANTIAL BODILY HARM (Violation of NRS 424C.110 and NRS 484C.430, a category B Felony) and COUNT II-DUTY TO STOP AT SCENE OF CRASH INVOLVING DEATH OR PERSAONL INJURY (Violation of NRS484E.010, a category B Felony). Possible action may be revocation of the Category I basic certificate.

9. DISCUSSION, PUBLIC COMMENT, AND FOR POSSIBLE ACTION.

Hearing pursuant to NAC 289.290(1)(e) on the revocation of James E. Vega's (formerly employed with the Laughlin Township Constables Office) Category I and II basic certificate(s) based on a conviction of, or entry of a plea of guilty, guilty but mentally ill or nolo contendere to a gross misdemeanor. The conviction(s) which have led to this action are: COUNT I: FALSE RESIDENCY STATEMENT BY CANDIDATE (Gross Misdemeanor – NRS293.1755-NOC 52502). Possible action may be revocation of the Category I and II basic certificates.
