NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Adoption of Regulations of the Commission on Peace Officer Standards and Training as proposed in LCB File No. R109-26

DATE AND TIME: TUESDAY, JULY 14, 2026 @ 10:00 A.M.

LOCATION: POST ADMINISTRATION BUILDING, CLASSROOM #2, 5587 WA PAI SHONE AVE., CARSON CITY, NV 89701

The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapter 289 of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603.

1. The need for and purpose of the proposed amendment.

Existing law requires the Peace Officer Standards and Training Commission to adopt regulations establishing minimum standards for the certification, decertification, recruitment, selection and training of peace officers. (NRS 289.510)

This regulation change will increase the minimum hours required for basic training for category I (from 480 to 725) and II (200 to 270) academies, bringing Nevada closer to the industry standards nationally. This regulation change will require all category I basic academies be in person and eliminate certain subjects from category I training. Subjects removed from the category I minimum standards are not category I subjects, which increased training hours in areas not as important for this category. This regulation change will put the focus back on actual category I training subjects.

2. For a proposed temporary regulation, the terms, or the substance of the regulation to be adopted, amended or repealed, or a description of the subjects and issues involved.

This is a permanent regulation.

3. For a proposed permanent regulation, a statement explaining how to obtain the approved or revised text of the proposed regulation.

EXPLANATION – Matter in *italics* is new; matter in brackets ~~[omitted material]~~ is material to be omitted.

AUTHORITY: §§ 1 and 2, NRS 289.510.

A REGULATION relating to peace officers; revising provisions relating to the minimum standard of training required for peace officers in training category I; revising the number of hours of training required for the completion of a basic course for peace officers in training category II; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law requires the Peace Officers’ Standards and Training Commission to adopt regulations establishing minimum standards for the certification and decertification, recruitment, selection and training of peace officers. (NRS 289.510) Existing regulations establish the minimum standard of training for peace officers in training categories I and II which require peace officers to complete a certain number of hours in certain basic training courses. (NAC 289.140, 289.150) **Section 1** of this regulation: (1) increases the number of hours of training in basic courses for peace officers in training category I from 480 to 725; and (2) requires peace officers in training category I to attend and complete basic courses in person. **Section 1** also eliminates certain subjects from the list of subjects required for inclusion in basic courses in training category I. **Section 2** of this regulation increases the number of hours of training in basic courses for peace officers in training category II from 200 to 270.

Section 1. NAC 289.140 is hereby amended to read as follows:

289.140 The minimum standard of training for officers in training category I is successful completion of a basic course that includes ~~[480]~~ 725 hours of *in-person* training in:

1. Law and legal procedures, specifically:
 - (a) Civil liability;
 - (b) Constitutional law;

- (c) Crimes against persons;
- (d) Crimes against property;
- (e) Juvenile law;
- (f) Laws governing coroners;
- (g) Laws relating to arrest;
- (h) ~~Laws relating to correctional institutions;~~
- ~~(i)~~ Laws relating to drugs, including, without limitation, current trends in drugs;
- ~~(j)~~ (i) Miscellaneous crimes;
- ~~(k)~~ (j) Probable cause;
- ~~(l)~~ (k) Rights of victims;
- ~~(m)~~ (l) Search and seizure;
- ~~(n)~~ ~~Searches of offender institutions;~~

(i) The DWI Detection and Standardized Field Sobriety Testing and the Advanced Roadside Impaired Driving Enforcement courses approved by the National Highway Traffic Safety Administration; and

(j) Unknown-risk and high-risk vehicle stops.

(b) Interpersonal communications;

(c) Lifetime fitness;

(d) Operation of emergency vehicles;

(e) Provision of emergency first aid and cardiopulmonary resuscitation;

(h) Tactics for the arrest and control of suspects, including, without limitation, methods for arrest and the use of less than lethal weapons;

(i) Training concerning active assailants;

(j) Training in the use of firearms; and
