### NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Adoption, Amendment and Repeal Of Regulations of the Commission on Peace Officer Standards and Training

PUBLIC HEARING NOTICE: The Commission on Peace Officer Standards and Training ("Commission") will be holding a Public Comment Hearing at 8:00 a.m. on Thursday, May 2, 2024, at the POST ADMINISTRATION BUILDING, CLASSROOM #2, 5587 WA PAI SHONE AVE., CARSON CITY, NV 89701. The purpose of the hearing is to receive comments from all interested persons regarding the adoption, amendment and repeal of regulations that pertain to Chapter 289 of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603:

### 1. The need for and purpose of the proposed regulations.

Existing law requires the Peace Officer Standards and Training Commission to adopt regulations establishing minimum standards for the certification and decertification, recruitment, selection and training of peace officers. (NRS 289.510).

R031-23RP2 will establish a Command Level Basic Certificate, awarded only to Executive Level Staff. Recruitment of executive level staff can be difficult, especially around elections. An elected official may have been certified but their basic certificate has expired. This certificate will assist in the recruitment and retention of Executive Level positions, including, but not limited to elected and/or appointed officials. In other instances, the certified elected official prefers to appoint an individual that has been out of law enforcement for more than 5 years. This new level of basic certificate and the process to achieve it will assist agencies in hiring personnel that can provide valuable insight, experience and knowledge. The process to achieve the certification is consistent with the reciprocity process, therefore allowing the individual to work while completing the online course and not having to complete a full, in person, basic academy, saving the agency valuable time and money.

2. For a temporary regulation, the terms, or the substance of the regulation to be adopted, amended or repealed, or a description of the subjects and issues involved.

This is a permanent regulation.

## 3. For a proposed regulation, a statement explaining how to obtain the approved or revised text of the proposed regulation.

4. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and, in each case, must include:

### (a) Both adverse and beneficial effects; and

- (1) Adverse effects: There will be a fee to the agency (\$200) payable upon enrollment.
- (2) Beneficial effects: Agencies will save time and money by having their staff attend the online course instead of paying for a full basic academy and losing a much-needed officer while they attend a full basic academy.

### (b) Both immediate and long-term effects:

- (1) The immediate effects: This will shorten the hiring process for executive level staff, for Nevada agencies. This will allow agencies to hire experienced staff who will be on the job during the process of certification.
- (2) The long-term effects: Agencies will have the ability to hire executive level staff that will bring knowledge and experience to their agencies.
- 5. The methods used by the agency in determining the impact on a small business.

The Commission on POST has reviewed the text of the proposed regulations. Because the regulation amends Nevada Administrative Code Chapter 289, dealing with certification provisions of the annual continuing education of peace officers, the proposed amendments to NAC Chapter 289 will have no impact on small business.

6. The estimated cost to the agency for enforcement of the proposed regulation.

There is no cost to the agency for enforcement.

7. A description of and citation to any regulations of other states or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

The proposed regulation does not overlap or duplicate any regulations of state, local or federal governmental agency regulating the same activity.

8. If the regulation is required pursuant to federal law, a citation and description of the federal law.

The proposed regulation is not required by federal law.

9. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provision.

There are no federal regulations that regulate the same activity.

10. Whether the proposed regulation establishes a new fee or increases an existing fee.

This regulation does not establish a new fee or increase existing fees.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

### SECOND REVISED PROPOSED REGULATION OF THE PEACE

### OFFICERS' STANDARDS AND TRAINING COMMISSION

EXPLANATION - Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted.

AUTHORITY: § 1, NRS 289.510.

A REGULATION relating to peace officers; establishing the requirements a peace officer must meet to receive a command level basic certificate; and providing other matters properly relating thereto.

### **Legislative Counsel's Digest:**

Existing law requires the Peace Officers' Standards and Training Commission to adopt regulations establishing minimum standards for the certification and training of peace officers. (NRS 289.510)

This regulation provides that the Commission may award a command level basic certificate to a peace officer if: (1) the peace officer has been elected or appointed to an executive level position; (2) the peace officer meets the minimum standards for appointment; (3) the peace officer has 5 consecutive years of experience as a peace officer employed by a Nevada agency; (4) any prior certification of the peace officer has not been revoked or suspended; (5) the peace officer has completed certain training courses; (6) the peace officer passes the state certification examination with a score of at least 70 percent; and (7) the peace officer passes a physical fitness examination approved by the employing agency of the peace officer.

**Section 1.** Chapter 289 of NAC is hereby amended by adding thereto a new section to read as follows:

- 1. The Commission may award a command level basic certificate to a peace officer if:
- (a) The peace officer has been elected or appointed to an executive level position;
- (b) The peace officer meets the minimum standards for appointment established pursuant to NAC 289.110;

- (c) The peace officer has 5 consecutive years of experience as a peace officer employed by a Nevada agency;
  - (d) Any prior certification of the peace officer has not been revoked or suspended;
- (e) The peace officer has satisfactorily completed a training course that is approved by the Executive Director which consists of a minimum of 80 hours of training that satisfies the requirements established by the Commission pursuant to subsection 1 of NAC 289.300 in:
  - (1) Abuse of older persons;
  - (2) Child abuse and sexual abuse of a child;
  - (3) Civil liability;
  - (4) Classification and receiving of offenders;
  - (5) Constitutional law;
  - (6) Counter-terrorism and weapons of mass destruction;
  - (7) Crimes against persons;
  - (8) Crimes against property;
  - (9) Cultural awareness;
  - (10) Domestic violence, stalking and aggravated stalking;
  - (11) Ethics in law enforcement;
  - (12) Fire safety and use of emergency equipment;
  - (13) Games offenders play;
  - (14) Gangs and cults;
  - (15) Juvenile law;
  - (16) Laws relating to arrest;
  - (17) Laws relating to correctional institutions;

- (18) Laws relating to drugs, including, without limitation, current trends in drugs;
- (19) Miscellaneous crimes;
- (20) Modern correctional philosophy;
- (21) Probable cause;
- (22) Public and media relations;
- (23) Records of offenders in institutions;
- (24) Rights of victims;
- (25) Search and seizure;
- (26) Searches of offender institutions;
- (27) Supervision of offenders;
- (28) Training concerning active assailants; and
- (29) Use of force;
- (f) The peace officer passes the state certification examination with a score of at least 70 percent; and
- (g) The peace officer passes a physical fitness examination approved by the employing agency of the peace officer.
  - 2. An agency may have only two active command level basic certificates at any one time.
- 3. To maintain a command level basic certificate, a peace officer must comply with the provisions of this chapter and chapter 289 of NRS.
- 4. A command level basic certificate expires immediately upon the separation of a peace officer from an executive level position unless, within 90 days after the separation, the peace officer is newly elected or appointed to an executive level position.
