**PLEASE NOTE:** The successful applicant will be required to pass a background investigation and polygraph examination. Please review the <u>ISP Drug Policy</u> and <u>ISP Grooming and</u> <u>Appearance Standards</u> to ensure compliance. Applicants must also complete psychological, medical, physical fitness and drug screening. Inaccurate, withheld, or concealed information will be cause for rejection. A conviction or withheld judgment for any local, state, or federal crime may be grounds for rejection.

**ISP ADVANCED TRAINING COURSE:** ISP provides a comprehensive program that incorporates POST certification into the ISP Advanced Training Course (ATC). This ATC will be held in Meridian, Idaho and is scheduled to begin July 9, 2023 with graduation December 08, 2023.

**LATERAL APPLICANTS:** In order to be considered as a lateral, you must hold a current POST Basic Patrol (or higher) Certificate, whether in Idaho or another state, and with at least three (3) years law enforcement experience in patrol.

**Lateral Portion of ISP Advanced Training Course**- ISP has developed a modified, yet comprehensive training program, starting on July 9, 2023. Lateral Recruits attend portions of the ISP Advanced Training Course in Meridian, then go to their assigned districts for Field Training. Lateral recruits will return to HQ the last week of the academy for graduation on December 08, 2023.

  - Must be a graduate of an accredited high school, or GED equivalent
  - Shall be a minimum of twenty-one (21) years of age
  - Possess a valid driving license from their state of residence and qualify for an Idaho driver's license
  - Fingerprint clearance by the Idaho State Police Bureau of Criminal Identification and the FBI. A conviction or withheld judgment for any local, state, or federal crime may be grounds for rejection
  - Successfully complete a background investigation
  - Attest to the Code of Ethics/Standards of Conduct on POST application

In the event that a suspect in custody is in need of medical treatment, the trooper should notify a supervisor immediately so that an ambulance can be summoned. Suspects who are drug addicts and who are in need of treatment for their addiction should be taken to a hospital by a radio car. 3. Under no circumstances should a trooper prescribe any medication for a suspect in custody. 4. A trooper should not attempt to diagnose a suspect's illness or injury and should not attempt to treat the suspect except in a situation where first aid is required.
