#### Formatta Updates

- The three Formatta forms "Employment Personnel Action Report, "Update Personnel Action Report" and the "Basic Certificate Application" have been updated to be easier for you to use. You no longer have to enter your agency ID number and agency name in the Employment PAR as this information is automatically displayed in the fields after you log into the form. The format of these forms has been streamlined to make data entry quicker for you. Please be sure to use these updated forms to ensure that all of the information in our database is accurate.
- After accessing the Formatta forms page, you will notice that there is another form icon under the "View" column. If you click on this icon, the form will open in your internet browser. This version of the form does not require the Formatta Filler software be installed on your computer; which may be helpful for MAC users and instances when you are working on a computer that does not have the Filler software installed. The look and feel of entering your information into this version of a form is somewhat different; however, using the form remains exactly the same — Enter the information and click "Submit."
